Volunteer SKYWARN spotters are the front line of defense against hazardous storms. Spotters help the National Weather Service provide early warnings to the public about severe damaging weather.

Antrim County Building Renovations: April 2024 Update

Installation of the new, more energy-efficient windows is nearly complete. Work on the new public entry is underway

(see photo). The yellow is sealant and will be covered with white metal siding.

Departments displaced since last June will be able to return to their offices once all the window interior trim work is final. The project remains on track for completion this spring.
