ROBIN Grant Applications

Thank you to the townships and villages who considered and approved letters of support for the State of Michigan’s ROBIN broadband grant. \$231 million in grant funding is available; network operators have applied for more than \$1.3 billion. Grant awards are expected later this summer.

Natural Hazard Mitigation Plan: Final Draft Version

The County Planning Commission has recommended that the Local Emergency Planning Commission forward the natural hazard mitigation plan to the Michigan State Police and the Federal Emergency Management Agency (FEMA).

If FEMA approves the document, the Board of Commissioners will consider the plan for final approval. A late 2023 date is expected for FEMA approval.

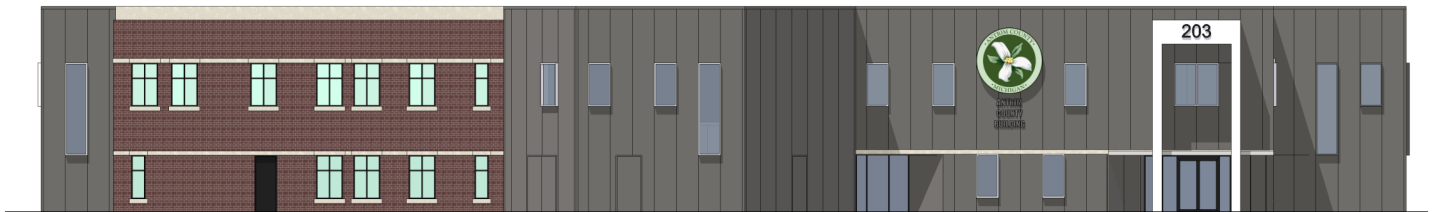
