Antrim County Sheriff Vacancy-

The position of Antrim County Sheriff will become vacant upon the retirement of Sheriff Daniel Bean, effective September 8, 2023. Per MCL 201.35, a statutory committee consisting of the judge of probate, the clerk, and the prosecuting attorney, shall appoint an interim Sheriff. Anyone interested in applying for the position, shall submit a written request/letter of interest to the Antrim County Clerk, P.O. Box 520, Bellaire, MI 49615 by June 8, 2023 at 5:00 p.m. As provided in Section 1 of Article XI of the State Constitution, the person appointed shall take the oath of office, grant bond in the manner required by law, and hold the office for the remainder of the unexpired term. The Antrim County Sheriff is an elected official. The open position will be on the 2024 ballot. A summary of the Antrim County Sheriff's duties and responsibilities have been posted in the local newspapers and on the County's facebook page.

County Building Façade-

Progressive AE and Spence Brothers were hired as the architects and construction managers for the County Building Exterior. It is expected that work will beginning in July and be completed by February 2024. The 6' tall fence around the building is scheduled for July 5th. The removal of the exterior panels and installation of the cold formed metal framing is tentatively scheduled to start in August. **Moved by Helwig**, **and seconded by LaVanway**, that the Board approve a budget for the façade replacement plan, not to exceed \$5 million and authorize the Finance Director to make a budget amendment of \$67,000.00 from 101.000-272.20-969.000 General Fund Contingencies. Motion carried as follows: Yes – Hefferan, VanAlstine, Helwig, LaVanway; No – Rubingh; Absent – None.

Exterior wall departments that will be relocated will be in their temporary offices for up to six months. The plans are to move equalization/GIS permanently into Room 120, move the Register of Deeds permanently into the equalization office, move the clerk temporarily during construction into the Register of Deeds current space, and move the Building Department permanently into the Register of Deeds current space after the façade construction is complete. Public parking plans are underway. **Moved by** LaVanway, and seconded by Hefferan, that the Board approve and authorize the expenditure of an amount not to exceed \$61,750.00 for the County Building offices renovation project and authorize the Finance Director to make all appropriate Budget Amendments. Motion carried as follows: Yes – Hefferan, Rubingh, VanAlstine, LaVanway; No – None; Absent – Helwig.

Health Dept. Building Renovations:

Progressive was hired in December to work on relocating the Sheriff Departments road patrol and undersheriff offices to half of the Health Department building in Bellaire. This has been a planned move since last year and it is being coordinated with the County building construction job for better pricing. The project is scheduled to begin the second week in June. Moved by Hefferan, and seconded by Helwig, that the Board approve and accept the health department building renovation bids as submitted by South Arm Construction and Top Line Electric contingent on satisfactory interviews and reference checks, to authorize \$228,480.00 for project construction and IT infrastructure, and to authorize the Board Chair to execute agreements with South Arm Construction and Top Line Electric. Motion carried as follows: Yes – Hefferan, Rubingh, VanAlstine,Helwig, LaVanway; No – None; Absent – None.

Public Safety Center (new jail)-

Byce & Associates were hired last year to outline a preliminary plan and renderings for a Public Safety Center. The Sheriff with a committee has worked together on a concept plan. 911 Tower-

A new 911 tower has been planned to improve communications for 911. Property Tax Forclosures-

If your property was taken and sold due to non-payment of property taxes, you could receive money from a recent court settlement. Forty-three (43) Western and Northern Michigan counties that sold tax-delinquent properties and kept the sale proceeds have agreed to return certain amounts in excess of the past due taxes and costs. This applies to sales between January 1, 2013 and December 31, 2020. You MUST file a claim by August 7, 2023, or you could lose your right to those funds. Commission on Aging and the Sheriff's office is working together to promote "Miles for Memories" –Help Home Personal ID Program. It's a new program to assist loved ones with dementia or autism to return home safely. The program provides waterproof hypoallergenic bracelets which hold a QR code for participants to wear. The code can be loaded with medical and emergency contact information by the advocate. This will help reunite the lost with their loved ones by simply scanning the bracelet with a smart phone. There is a small monthly cost to users and is serviced through Verizon. The bracelets will be distributed at the COA office by appointment only if you know of someone that needs one.
