Park Coordinator Position-

The Park Coordinator position according to state law will have to receive benefits in the winter months due to the position working eight months and the County has more than 50 employees. Due to not being a union position, the person can help with another department if needed during the winter months if there is not much work for this position. This is a position in which they will be working on maintaining the parks, writing grants and making sure things are ready for spring.

Moved by Bargy, seconded by Ricksgers, the Board approve the change of the Park Coordinator position from seasonal to part-time

Full time jail cook-

The part-time jail cook position has been open and advertised for over a year, with no credible applicants. The County hoped to increase the position to a second full-time position to encourage more individuals to apply.

Moved by Helwig, seconded by Bargy, to approve increasing the parttime cook in the jail to a full time cook position and authorize the appropriate budget amendment. Yes-Bargy, Boettcher, Ricksgers, Helwig, Marcus; No-Rubingh and LaVanway; Absent-Watrous and VanAlstine.

MAINTENANCE OF BUILDINGS-

County Admin Building-

Tom Frey, Progressive AE Construction Management (CM) firm addressed the Board on the Antrim County Building Facade Plan options.

Motion by Bargy, and seconded by Rubingh, that the Board approve to TABLE the County Building Facade Plan pending further discussion and planning. Motion as follows: Yes – Rubingh, Bargy, Ricksgers; No – Boettcher, VanAlstine, Helwig, LaVanway, Marcus; Absent – Watrous. MOTION TO TABLE – FAILS

Moved by Boettcher, and seconded by LaVanway, that the Board approve the facade replacement plan and budget provided by Progressive AE, Inc. and proceed with an amendment to the contract with Progressive AE, Inc. to provide specifications and drawings for the full building façade replacement option, with a corresponding budget amendment of \$3.45 million to come from the American Rescue Plan Act (ARPA) Funds. Motion as follows: Yes – Boettcher, VanAlstine, LaVanway, Helwig; No – Rubingh, Bargy, Ricksgers, Marcus; Absent – Watrous. TIE VOTE – FAILS

Rubingh brought the motion back on the August 18th meeting agenda. Discussion followed.

Moved by LaVanway, seconded by VanAlstine to approve the façade replacement plan and budget provided by Progressive AE, Inc. and proceed with an amendment to the contract with Prograssive AE, Inc.

to provide specifications and drawings for the full building façade replacement option, with a corresponding budget amendment of \$3.45 million to come from the \$4.5 million American Rescue Plan Act Funds from the Federal Government. Motion as follows: Yes- Rubingh, VanAlstine, LaVanway, Ricksgers, Helwig; No-Marcus, Watrous, Bargy. Absent-Boettcher. Motion passed.

Commission on Aging-

Flooring will be replaced for the entire seating area and back storage room tentatively scheduled for October 3 - 7.

Sale of County Building-

The County Maltby building (Nifty Thrifty) will be for sale with Dave Ciganick as the realtor and will be paid out of the proceeds of the sale.

Motion by Boettcher, and seconded by Helwig, that the Board approve and authorize the amended Agency Agreement for Commercial Properties (Properties for Sale), the Disclosure Regarding Affiliated Business Associations, and the Disclosure regarding Real Property Estate the Maltby Building (Nifty Thrifty) and approve a listing price of \$129,900. Discussion followed. Motion carried as follows: Yes-Rubingh, Bargy, Boettcher, Ricksgers, Helwig, Marcus; No-LaVanway; Absent-Watrous and VanAlstine.

Walk through Barnes Park:

A walk through of the park is scheduled for Sept. 16th at 4 p.m. to show people what the plans are for improving the park with more campsites, reforest the central field and expand the playground with new equipment and trails to the bathrooms. There is also emphasis on barrier free improvements.

Natural Hazards Mitigation Plan (NHMP)-

Leslie Meyers, Emergency Service Coordinator has created a draft plan to follow if a natural hazard or disaster should happen within the County. Creating and updating hazard mitigation plans follows a defined process of identifying hazards within the county, analyzing the risks posed by those hazards, establishing priorities for addressing those risks, and choosing specific actions that will mitigate those risks. Under the Disaster Mitigation Act (DMA), state and local governments are required to adopt a state or local hazard mitigation plan (LHMP) approved by FEMA in order to qualify for federal hazard mitigation project grants. Hazard mitigation plans are valid for five years from the date of FEMA approval. You can find the current plan at the following:
