#### Two Jail Tours Scheduled in October

Antrim County voters will be asked on November 5 whether or not to approve a bond proposal for the construction of a Public Safety Center. To help voters with this decision, tours of the existing jail are currently scheduled for:

• Fri. 10/11 at 3 pm • Fri. 10/25 at 3 pm

Tours last approximately half an hour. The jail's address is 207 E Cayuga St., Bellaire. Parking is available in the County Building's parking lot. Since the jail is a working facility with limited space, tours are restricted to 15 people.

The tour will be offered on a first-come, first-served basis. Reservations are not required. Those who take the tour will be required to be respectful of the inmates. No one under the age of 18 is allowed to tour the jail.

## **County Building Parking Lots: Closed Temporarily in Late September**

Reconstruction of the parking lots adjacent to the County Building is scheduled for Thursday, September 19 through early October. The first phase is demolition of curb and some sidewalks. This is scheduled for September 19 & 20. During that time, some public parking will be available in the Cayuga Street lot.

The second phase, scheduled to start September 23, is new concrete, then asphalt removal & regrading. During that time, no parking will be allowed in any lots next to the County Building. Parking will be available in the 1905 Courthouse lot off Broad Street. The third and final phase is paving, tentatively scheduled to start on October 1.

Parking lots might be open between grading and paving, but that cannot be guaranteed. All dates noted above are weather dependent. Everyone's patience with this muchneeded project is appreciated.

## **Drop Boxes: Back at the County Building**
